

## Grants: Terms & Conditions

When submitting an application, applicants must agree to the declaration below, for their application to be reviewed:

- the information that they have provided in the application form are accurate
- they have the full backing of their organisation to apply for the grant
- they agree that if for any reason the equipment is not purchased, the event not attended or the project not completed, the full grant awarded will be returned to the Society
- As required by the Society, they agree to:
  - o present at a future Society meeting
  - $\circ$  write an article to appear in the Society journals and/or website
  - provide copyright-free images of the project or taken whilst completing the project which could appear in Society journals and/or website
  - acknowledge the Society funding in all presentations, press releases, and activities relating to the grant output
  - provide any tangible outcomes of grant funding, which may include but is not limited to, factsheets, teaching materials, event programmes, to the Society to be hosted on the website
  - provide an interview with, or complete a case study form, which will be used to promote the outcome of the grant award to other members and the wider public via Society journals and/ or website.

As set out above, successful grant applicants will be notified which supporting activity they will be required to undertake on notification of their grant or award.

All grant applications will be reviewed without bias, and personal details and location will be redacted.

Any intellectual property created as a result of grant funding will be owned by the creator but the Society must be acknowledged and the property will be available for the society's dissemination.

## Article

Where an article is requested, we would require 500 - 800 words, submitted within two months of receiving funding (Early Career Conference Grant) or 800 - 1,000 words, submitted within six months of receiving funding (all other grants).

In each case, the recipient should provide a colour headshot, along with any accompanying photographs to <u>admin@soils.org.uk</u>.

## Photographs

Where photographs of the project are requested, we will require a disclaimer to be completed by all those featured in the photographs. Please see the Photograph Disclaimer Form at the end of this document.
